**PARENTAL CONSENT FORM  
RELEASE AND WAIVER OF ALL LIABILITY  
AND ASSUMPTION OF RISK AGREEMENT**

FOR GOOD AND VALUABLE CONSIDERATION, including permission for to participate in the DAISY AVENUE CHRISTMAS TREE LANE PARADE and related activities, I, the parent/guardian of the minor for myself and on behalf of the minor:

- I. Consent to the minor's participating in the event or activity;
- II. Agree that prior to minor's participation in the event or activity the minor and I will inspect the facilities, equipment and areas to be used, and, if either of us believes any of them are unsafe, I will immediately advise the person supervising the event, activity; facility or area;
- III. Acknowledge that the minor and I fully understand that the minor's participation may involve risk of serious injury or death, including economic losses, which may result not only from the minor's own actions, inactions or negligence, but also from the actions, inactions or negligence of others, the condition of the facilities, equipment or areas where the event or activity is being conducted, the rules of play of this type of event or activity;
- IV. Release, waive, discharge and relinquish the City of Long Beach and their officers, employees and agents from any liability; loss, damage, claim, demand or cause of action against them arising from or attributable to my participation in the event or activity, whether same shall arise by their negligence or otherwise;
- V. Assume any and all risks of bodily injuries to the minor and authorize the City of Long Beach or their agents to contact a licensed physician to render any medical treatment that may be deemed necessary for the minor or to take and admit the minor to any hospital. If such medical treatment or hospitalization is required, I agree to pay all medical and hospital bills relating thereto, permanent or partial disability; or death and damages to the minor's or my property; caused by or arising from my participation in this event or activity;
- VI. Covenant not to sue, or present any claim for personal injury; property damage or Wrongful death for on behalf of the minor against the City of Long Beach and their officers, employees and agents for damages attributable to the minor's participation in the event or activity;
- VII. Agree that photographs, pictures, slides, movies or videos of the minor may be taken in connection with the minor's participation in this event or activity without compensation from the City of Long Beach and consent to the use of these photographs, pictures, slides, movies or videos for any legal purpose;
- VIII. Warrant that the minor is in good health and has no physical condition that would prevent the minor from participating in this event or activity;

IMPORTANT: THIS DOCUMENT RELIEVES THE CITY OF LONG BEACH AND OTHERS FROM LIABILITY FOR PERSONAL INJURY, WRONGFUL DEATH AND PROPERTY DAMAGE BY NEGLIGENCE. BOTH PARENTS MUST SIGN UNLESS ONLY ONE PARENT IS LIVING OR UNLESS ONLY ONE HAS LEGAL CUSTODY. LEGALLY APPOINTED GUARDIAN S MUST SIGN AND FURNISH A CERTIFIED COPY OF LETTERS OF GUARDIAN SHIP. I HAVE READ THIS DOCUMENT, UNDERSTAND THAT I GIVE UP SUBSTANTIAL RIGHTS BY SIGNING IT AND SIGN VOLUNTARILY.
