EXTENDED DAY FEES: The monthly rates are based on a 180 day school year and are pro-rated over a ten month period. You are charged for only the days that school is in session.

Registration: \$50 per student for **all** grade levels, Pre K 3 – Grade 8, with a maximum of \$100 per family. **Please register by August 1.**

Occasionally families may need care and for those times we charge \$5 for morning care and \$8 per hour for afternoon care. All children needing care must pay the \$50 registration fee for Extended Day.

Extended Day Parent Contract

In consideration of my child/ren's participation in the Extended Day Program, I agree to the following:

1. I agree to pay a non-refundable registration fee of \$50 per student in all grade levels, Pre K 3 – Grade 8, with a maximum of \$100 per family.
2. I agree to pay an amount determined by the number of sessions my child is attending. I agree to remit each month's fees upon receiving my monthly statement. I understand that there is a \$30 late fee of payments made after the 5th of each month.
3. I agree that I will pick up my child by 6:00 pm or earlier. I understand that in the event my child is not picked up by 6:00 pm, a fee of \$15 within the first fifteen minutes (until 6:15 p.m.) and \$1.00 per minute per child thereafter in addition to the charges for that day will be assessed. After 6:15 p.m. my emergency contact will be called.
4. I agree to walk in and personally pick up my child from the Extended Day room.
5. I agree that Sacred Heart Catholic School will be held free and harmless from any and all injuries occurring to my child, except as to such injuries that directly result from acts of negligence on the part of the Sacred Heart School Staff.
6. In the event of an emergency, I give my permission to the staff member to have my child treated by medical personnel. The staff member in charge shall make reasonable attempts to contact me prior to any emergency medical treatment.
7. I understand that in the event of late payment, late pick-up of my child, or for any other good cause, the Sacred Heart administration or his/her delegate reserves the right to remove my child from the Extended Day Program for the remainder of the year.
8. I understand that the Extended Day Program is an extension of the school and that all rules and policies apply.
