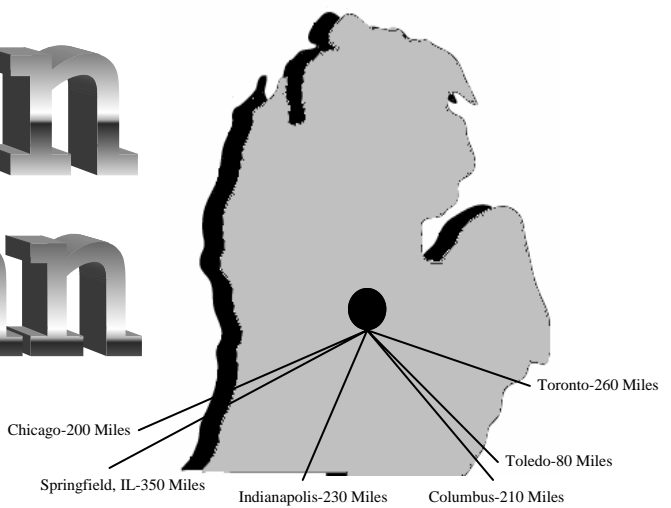

- In all cases, the horse is sold to the highest bidder. **ALL SALES OR TRANSACTIONS MADE ON THE SALE GROUNDS MUST BE REPORTED TO AND MADE THROUGH THE SALE OFFICE.**
- The horses consigned to this sale are entirely at the risk of the consignor until sold and fully paid for. The auction company is acting simply as an agent.
- **Each sale horse must have a negative Coggins Test dated within the current calendar year (2010), this is required! Health papers are required for out-of-state horses.**
- HORSES CONSIGNED FROM CANADA MUST BE INSPECTED AT THE PORT OF ENTRY PRIOR TO SALE. PHONE (810) 985-5433 (PORT HURON) OR (313) 226-4428 (DETROIT). Closed Saturday & Sunday.
